In accordance with instructions received from **Galmarley Ltd t/a BullionVault**, we have performed an independent inspection and audit of the London Good Delivery Gold Bars captioned below and our findings are as follows:

#### QUANTITY

A total of 2,276 London Good Delivery Gold Bars.

#### BAR MARKS/DESCRIPTION OF BARS

All 2,276 bars were stamped in accordance with London Good Delivery specifications and were in a good, clean sound condition.

#### STORAGE

The 2,276 London Good Delivery Gold Bars vaulted in Malca Amit were contained on 29 wooden pallets. All of the pallets were secured with three poly straps (all intact). The pallets were each numbered and marked with the storage place, number of the pallet and the rows of ingots on top of it. The pallets were in a sound condition.

#### INSPECTION

On arrival at the vault, permission was given to inspect the bars in a designated inspection area. On completion of the audit the pallets were returned to their respective vaults. Each bar was inspected and the marked data compared with the Malca Amit Master Stock Bar List and the Galmarley Ltd t/a BullionVault list published on 1<sup>st</sup> November 2019.
